**DISCUSSION ITEMS:**

Inclusion of NATA Code of Ethics under definition of unprofessional conduct in Athletic Trainer Licensing Act Rule, Utah Admin. Code R-156-40a)

Mr. Oborn reviewed the proposed rule change to include the NATA Code of Ethics. Mr. Oborn will complete the proposed rule filing process and try to set the public hearing for October 20, 2011 at 9:00 A.M. Mr. Oborn noted that the hearing will hopefully be held the same date as the next Board meeting.

Upcoming Board vacancy

Brad Nelson's final term as a Board member ends on June 30, 2011 and there is a vacant position on the Board that has not been filled since Bill Bean left the Board. Mr. Oborn advised the Board that the names of replacements were submitted to the Governor's office for appointment. The Division hopes to have

the Governor's office approve the appointments by September 2011.

Mr. Oborn noted that due to recent statute changes during the last legislative session, Mr. Nelson may continue as a Board member until his replacement is appointed.

Licensing Statistics

Mr. Oborn noted that as of June 1, 2011 there are 350 licensed athletic trainers.

Upcoming Athletic Trainer Regulatory Conference, July 8-9, 2011 in Omaha NE

Mr. Oborn shared information about the upcoming Athletic Trainer Regulatory Conference on in Omaha, NE. Mr. Oborn stated that because the State is in a travel freeze at this time, the Division is not able to send a Board member. Mr. Oborn will share information about the conference with the Board at the next Board meeting.

Bill passed during 2011 General Legislative Session that created stricter penalty of practicing athletic training w/o a license

Mr. Oborn shared that the Division now has fine and citation authority for the practice of unlicensed individuals.
