Ms. Woodford reported she received a compliant that Ms. Wachel was practicing nursing in Utah without a license. Ms. Wachel is located out of state and was conducting case review. Ms. Woodford reported that once Ms. Wachel was made aware that she needed a Utah license, she immediately began the application process and is currently licensed in Utah. Mr. Allred made a Motion that no further action be taken and

noted that the Board felt Ms. Wachel is in compliance with the Nurse Practice Act and Rules. Ms. Schilleman seconded the Motion. All Board members in favor.

Education Committee report:

Ms. Brown reported the Memorandum of Understanding for Broadview University had been signed. Broadview University representatives met with the Education Committee and submitted a plan of remediation. Committee members recommended that the Memorandum of Understanding be accepted. All Board members in favor.

Ms. Brown also indicated that letters of warning will be sent to all nursing education programs with NCLEX pass rates 5% below the national pass rates two times within the last two years. All Board members voted in favor of sending the letters of warning to the appropriate programs.
