DISCUSSION ITEMS:

Athlete Agent Information Pamphlet

A copy of this pamphlet was given to Mr. Gasser to review. It was determined the following items should be revised: 1. Remove the first part of the 3rd question "Did you graduate from law school?" from the questions that should be asked of a potential agent under *Deciding on an Athlete Agent*, as graduation from law school is not a requirement for licensure; 2. Consolidate 4th, 5th, and 6th items from the questions that should be asked of a potential agent under *Deciding on an Athlete*, as they are redundant; and 3. Clarify and break into several sentences the second paragraph under *Notice to*

Educational Institutions.

Training Meetings at Colleges

Mr. Ormond explained the Division is planning to meet with the different colleges to explain what the athlete agents can and can not do according to the statute. Mr. Gasser stated he would be willing to go to the meetings and help communicate this from an athlete agent's perspective.

Athlete Agent List on Website

Mr. Ormond stated a list of Athlete Agent licensees is now available to be printed from the website. Mr. Gasser suggested adding the name of the agency the athlete agent is working for to the list. At this time only the name and license number is available on the list. Mr. Ormond explained why addresses and phone numbers are no longer available on the lists.

Renewal Form

A copy of this was given to Mr. Gasser. Mr. Ormond explained if the license were renewed, by the date that will be stated on the form, there would not be a lapse in the license.
