REVIEW 2009 INTERNATIONAL
ENERGY CONSERVATION CODE

William Chatwin and Eric Mackell spoke to the committees in connection with the 2009 International Energy Conservation Code. They discussed the estimates on costs to build a home using the 2006 code versus the 2009 code.

Questions were raised about how the possible adoption of the 2009 code will affect the

stimulus package. William Chatwin pointed out that there has to be 90% compliance with the energy code within 8 years. Dianne Nielson will bring more information to the August meeting.

**REVIEW PROPOSED AMENDMENT TO
IRC SECTION M1411.6**

The committee reviewed the proposed amendment. Ray Moore made a motion to approve the proposal with a modification of deleting the words "locking type". Mark Eldredge seconded the motion and the motion passed unanimously.
