ADMINISTRATIVE BUSINESS:

MINUTES

A motion was made by Dave Webster and seconded by Mark Eldredge to approve the minutes from the July 7, 2009 meeting as corrected for the Mechanical Advisory Committee. The motion passed unanimously.

Approval of the minutes for the Architectural Advisory Committee was deferred until the next meeting as there was not a quorum present.

DISCUSSION ITEMS:

REVIEW 2009 INTERNATIONAL ENERGY CONSERVATION CODE

Dave Webster and Doug Weidauer gave a report on the information they gathered in talking to contractors about the 2009 IECC. Scott Marsell pointed out some of the concerns that have been pointed out at the ad hoc committee meetings.

Those present reviewed and discussed the letter from Dianne Nielson requesting support in the adoption of the 2009 IECC and the ANSI/ASHRAE/IESNA Standard 90.1-2007 in order to comply with the State Energy Program under the American Recovery and Renewal Act of 2009.

A recommendation was made to consider adopting the IECC for the commercial side but delay implementing the requirements for the IRC and stay at the 2006 IRC energy provisions until further costs studies could be made over

the interim. This further study could continue and come back with a recommendation next year rather than this year.

The Mechanical Committee unanimously voted that this would be their recommendation to the Building Code Commission, for this year's code cycle, if they could not get these adequate studies prior to the date they are required to make a recommendation to the Building Code Commission.

The committees asked that the energy code be placed on the next meeting agenda to consider what final recommendation they will make to the Building Code Commission regarding the energy code.

The next meeting will be on September 1st at 2:00.
