MINUTES

REVIEW 2009 CODES AND CURRENT AMENDMENTS

The committee held a conference call with Ron Schneider, Utah Sign Association, in connection with the current amendment for Section 1609.1.1. Stephen Cohen outlined four possible options for this amendment. Following a discussion by all, the current amendment was modified. A motion was

made by Stephen Cohen and seconded by Don Barker to approve the modifications to the current amendment. The motion passed unanimously.

The committee discussed special inspections for R-3 occupancies designed under the IBC and felt that a special inspection was necessary due to the size of the home. Jerry Thompson made a motion to accept the requirement as is. The provisions are in the new code without change. The motion was seconded by David Alter and passed unanimously.

**MAKE AN OVERALL  
RECOMMENDATION FOR THE  
STRUCTURAL PORTION OF THE 2009  
IBC, IRC, AND IEBC**

The committee discussed the structural portion of the IBC and what recommendation to make. A motion was made by Don Barker to make a recommendation that there is no substantial advantage or disadvantage between the structural portions of the 2006 and the 2009 codes, however, we are recommending to go to the 2009 codes to be consistent with other professions. The motion was seconded by Richard Lewis and passed unanimously.
