APPROVAL OF MINUTES

A motion was made by Greg Allen and seconded by William West to approve the minutes from April 12, 2006. The motion passed unanimously.

REVIEW 2006 EDITION OF THE IBC, IRC AND CURRENT AMENDMENTS

The Committee reviewed the current amendments and chapters per the assignments from the last meeting. Chapters 1 – 3 were reviewed and reported upon by Cary Campbell. It was moved by Cary Campbell and seconded by William West that the amendments be recommended to the Commission to be retained as written. The motion passed unanimously.

Chapters 4 – 9 and amendments 15 – 22 were tabled until the next scheduled meeting due to the absence of Steve Froebe.

William West provided a written report (review) of Chapters 10 – 12 and amendments 23 – 29. His recommendations for changes or corrections were moved by Greg Allen to be the recommendation(s) of the Committee to the Commission as written. The motion was seconded by Cary Campbell and passed unanimously.

Greg Allen reported on Chapters 14, 16, 18 & 25 for amendments 30 – 56. The Committee determined in discussion that they should recommend amendment 30 as is. Amendments 31 – 56, with some numerical or cosmetic corrections, were to be referred to the Structural Advisory Committee. It was so moved by William West, seconded by Greg Allen and passed unanimously.

Dave Levanger was not present to provide his review of Chapters 18, 23, 29, 30, 34 & 35 with their corresponding amendments 50 – 55 and 57 – 64. Their review was tabled until the next scheduled meeting. His absence also resulted in tabling the review of the IRC and its current amendments.

The local amendments, as reviewed by Michael Martin, were also tabled for review at the next scheduled meeting.
