- Supporting documentation for any "yes" answers provided on either the "Qualifying Questionnaire" or "Medical Qualifying Questionnaire" (Pages 2 and 3).
- Official transcripts documenting completion of:
 - Doctoral Degree in Audiology if applying for an Audiologist license
 - Master's Degree in Speech Language Pathology if applying for SLP

APPLICANTS HOLDING ASHA CERTIFICATION

If applying for Initial Licensure and you hold a current ASHA Certification, in addition to the items required for all applicants, you must submit:

- Documentation of your current ASHA Certification

APPLICANTS WITHOUT ASHA CERTIFICATION
